While that is Father's Day, your Board of Directors nonetheless thought we should explore seeing if JCOP can obtain tickets and join the cruise with the Miata Club to the Playhouse and wherever they are going to eat. Amanda Lawson isin the process of following up to see about such arrangements. Details will be forthcoming.

Now for the "business side" of things. I attended the Jaguar Clubs of North America Annual General Meeting in Burlingame, CA on behalf of JCOP from March 10 through 12, 2023. I actually arrived early in the morning of June 9, since I obtained the only non-stop flight from Pittsburgh to San Francisco and to do so on March 10 would have caused me to miss some scheduled events. I ended up volunteering with the Jaguar Associate Group (the San Francisco Bay Area Jaguar Club that hosted the SGM; they go by the acronym "JAG") to set up and help with any number of "busy-work" arrangements for all those arriving that night or the following day. The members of JAG were just the nicest and most welcoming folks you could ever meet and they certainly welcomed another set of hands, even if they were from some Western PA interloper. I am sure you are aware of the brutal weather out there in the San Francisco Bay area this winter and for the most part it rained, and rained some more, during the AGM. For example, the folks from the Jaguar Club two hours away in Sacramento, CA called on Saturday morning to say they could not be there due to flooding of roads, power outages, and such. One of the JCNA Directors (JCNA Past-President and JAG member), Les Hamilton, had to leave the AGM Hotel on Friday evening to drive back to his home in the Monterey area since they had a long power outage and Mrs. Hamilton was not comfortable trying to figure out how to obtain power with Les' generator. Les missed the AGM presentations he was to make on Saturday but we had his written materials to read and he returned for the Saturday night awards dinner. In any event, you can feel smug (if you wish) that our Pittsburgh winter weather was envied by everyone in the San Francisco Bay Area, if not most of California. With that said, one intrepid member of the San Antonio Jaguar Club drove his Jaguar more than two thousand miles to attend the AGM and he arrived without a problem !

Let me provide a report on the AGM.

It was important for JCOP to have at least one representative present, in person, at the AGM and I respectfully submit this is something that needs to be done indefinitely. There is no other way to both appreciate the "temperature" of what is going on with Jaguar and Jaguar clubs throughout North America as well as be able to provide input to JCNA from those of us at the club level.

With this being my third AGM and now understanding better how things work and what people are responsible for what tasks, I can share with you that I believe JCNA has a Board of Directors of wonderful people who are committed to doing the best they can do not only for JCNA but for all the member clubs. I am impressed with the Officers of JCNA, the Regional Directors for JCNA that I have met or from which I have heard , and those others that serve on Committees for JCNA. I heard from (and met) Jack Humphrey, a really nice (and impressive) fellow who is employed by JCNA and is responsible for a number of matters including IT. Jack presented as being completely devoted to being on call 24/7 for clubs who have questions, needs, or issues involving JCNA for which he may be of assistance. He is working to revamp the JCNA website to make it more modern and user-friendly at the same time.

JCNA dues from clubs are to be paid by February 15 of any given year; recognizing that all clubs may not have had all their members pay their dues to the clubs by then, the protocol is for the clubs to tender their Rosters with dues paid by those members by February 15 and then as additional dues come in, updated Rosters are to be sent by the clubs to JCNA with the additional dues. **Continued on next page** 





In order for JCOP to provide an accurate Roster to JCNA, we need accurate names, addresses, phone numbers and email addresses from you. These days Email addresses have become nearly as important as Social Security Numbers used to be in many regards. In terms of managing information to JCNA and JCOP members, please ensure your updated Contact Information is provided annually to our Treasurer, Cecile Canales, with your dues renewal every year. The Form is included in each edition of Jaguar Jargon and is also on the JCOP website jaguarclubofpittsburgh.org . If anyone needs the password to get into the Members-only section of the website, please call me.

After many years of Mike Meyer being our Regional Director (for the North Central Region of JCNA), Mike decided to stand down and Gary Cunningham from the Detroit, MI area is our new Regional Director along with John Boswell (who is also the President of JCNA and is from Wisconsin). We are at one end of the North Central Region and John Boswell is at the other end. Gary is in the middle. While we will miss Mike Meyer as our Regional Director, who served us so well, we feel confident we will continue to see him at our Concours. So many of the JCOP members consider Mike as a friend. Gary Cunningham is well known by Dave Gamret since they were in the Michigan Club together and during the AGM I spent some time getting to know Gary.

The issue of the financial health of JCNA is always a mainstay of every AGM and the 2023 AGM was no exception. JCNA does a five year financial projection every year. In 2019 the projection showed financial peril unless there was a \$10 per member dues increase, which the Board of Directors then did adopt after hearing from the clubs at the AGM (FYI: JCOP paid the entire dues increase to JCNA but did not impose that full dues increase on each of the JCOP members, instead we have been paying out of the JCOP Treasury for most of it these past years). It was projected that JCNA could not operate a breakeven level or better, let alone return to financial health needed. While the JCNA dues increase did improve the financial health of JCNA (and put them back on a projected target for having a reserve of one year of consolidated operating expenses by later in this decade), while the 2022 balance sheet of JCNA showed the first surplus since 2017, the 2023 financial projections showed that JCNA would be broke by 2028 without something changing. This contrast seemed striking and surprising to those of us receiving the large packet of information from JCNA to review before the AGM. Once at the AGM and hearing candid presentations and some line by line review of the financials we learned there are any number of reasons for this current projection and to the credit of JCNA they did not hide behind any of the reasons. I could take a page or two to itemize all the details but suffice it to say that even the most cold-hard scrutineer of the financials had to concur that "things had changed" in the world since the 2019 financial plan was put into effect. So JCNA either has to increase dues, or increase the number of members paying the current dues, or decrease expenses or do some or all of the above. And do so creatively, if possible...

Perhaps the largest and most obvious place to deal with expenses is the cost of printing and circulating by the USPS a hard copy of the outstanding Jaguar Journal magazine. But this issue is not as simple as it may seem on the surface. Sure, JCNA could (and probably will) go to electronic distribution some time sooner rather than later for Jaguar Journal. Doing so could save up to \$10 of dues per member, per annum. But this is only 1/3 of the cost of Jaguar Journal and the other 2/3 of the cost would still exist even in electronic format. Questions arise in this decision including: (1) will the advertisers still place the same ads if there is only electronic distribution? ; (2) if a small change in paper stock to a lesser paper is made (samples were passed around the room and very few people could tell the difference between the current paper stock and a lesser-cost proposed stock), it could save a not-insignificant amount of cost. Similarly, it is projected the cost of the paper will decrease this year whereas a couple years ago during the pandemic, Jaguar Journal locked in a rate for the current paper cost to be able to guarantee supply but this ended up not being a good deal through hindsight. **Continued on next page** 





There were many other relevant considerations to this issue and the Board of Directors of JCNA is going to have to make a decision on this entire matter. We will await the report in the next Jaguar Journal regarding the most recent meeting the JCNA Board of Directors had on Sunday, March 12, but my understanding from what I heard on Sunday after the JCNA Board of Directors meet all that morning (my flight home to Pittsburgh did not leave until 11:30 PM Pacific Time on Sunday so I had the whole day to kill after the AGM was over but the JCNA Board still had their meeting Sunday morning) is that the Board is going to see how things go with the costs over the next few months regarding supply issues and inflation and cost of new paper stock for the Jaguar Journal and then make a decision by August regarding any needed dues increase. John Boswell, President of JCNA, openly announced that he does not want to be the first President of JCNA to have dues double in amount during his tenure and he will work to do anything possible to have this not occur but, concomitantly, he would not be acting responsibly if he were to let JCNA not be on a path to be fiscally solvent so ultimately he cannot say a dues increase for 2024 is not possible. I can say I was impressed that the JCNA Board of Directors is going to explore every way to increase revenue and membership and we can be of assistance in that latter regard.

Fred Hammond, the JLRNA (Jaguar Land Rover North America) Liaison to JCNA, is always a pleasure to speak with and hear from. While affiliated with JLR, Fred always "tells it like it is" and he is a real car person, not to mention very knowledgeable. My takeaway from Fred's presentation and my discussions with him outside the room is that JLR does not currently have a firm plan on how they are going forward. We know that recently their US President was let go. It is now known that JLR was just about ready to pull the wraps off of a brand new XJ model with many people predicting it was a gorgeous luxury automobile. Jaguar then, at the last minute, pulled the plug on the new XJ. Whether it is because so many people are now purchasing SUVs and not cars (except sports cars and Jaguar says they are going to cease producing the internal combustion engine F-Type despite it having been received so spectacularly by the automotive community) or whether due to other reasons, this action of no new XJ is symbolic of the unknown future, and direction, for the Jaguar brand. Jaguar seems to becoming subservient to Land Rover in the JLR hierarchy and folks fear that if there are few, if any, new Jaguar automobiles being purchased or even being made, the Jaguar SUVs could become a warmed-over version of a Land Rover but with a Jaguar nameplate. Certainly, the consumer has the power of the purse in buying what they want and Jaguar is at risk of becoming second to Land Rover.

So this development also has a connection to JCNA since JCNA has a working group exploring the considerations applicable to whether to allow Land Rover owners to become members of JCNA. A review of corporate governance documents and many considerations are being investigated and a decision to allow Land Rover owners to join JCNA could provide impetus for them to join JCOP. More members so maybe not a bad idea as long as Jaguar remains extant as the organization. Something to ponder but for many of us, it seems "the more, the merrier" as long as we do not give up anything Jaguar.

In terms of Concours and judging rules, these have been contentious topics at AGMs. I have to say, however, that this AGM seemed different. The Judging and Concours Committee folks presented to the clubs in a fashion as though we were all partners and in the swimming pool together, rather than – as seemed to be in the previous two AGMs I attended - the committee people being like lifeguards trying to direct the clubs without doing what the clubs felt was best for all. The attitude of true camaraderie on judging and concours rules at this 2023 AGM really carried over into the many matters on the Agenda for discussion and voting. Yes, there is a new 2023 Chief Judges Rule Book. There is a primer of 143 pages on the JCNA website covering the many changes. There are 2023 Administrative Rule Changes. For example, instead of "Training Sessions" for judges the education will be called 'Judging School" and the sessions have to be held more than 30 days before any Concours in which the judge participates.

There will be no Chief Judge Test In 2023 or 2024 but likely will be one in 2025; again, it is not to "test" the Chief Judge per se but to demonstrate to the Chief Judges what rule changes have been implemented and the "test" is not only open book but next to each question it directs the judge to the place(s) in the rule book where the answers lie. The thought process is this will help Chief Judges outline what to educate their Judges on at Judges School regarding new rules. For the first time the clubs at the AGM did not act as a tsunami in opposing this approach since so many concours results throughout the country were invalidated in the last two years because of stupid errors on very basic matters by Chief Judges. (FYI: JCOP has, in Bryan Williams, a Chief Judge of the highest caliber and he is most respected in JCNA and none of JCOP's concours reports resulted in any changes or disqualifications at the JCNA level.)

Perhaps most emblematic of the attitude of the Judging and Concours committees were their replies to Bryan Williams' comments to me in regard to a proposed rule change for Concours, in the Driven Class, requiring all owners to open the bonnets of the cars before any judging so that the judges could determine there was a Jaguar engine powering the vehicle. Bryan felt that requiring this be

done, en mass, at the beginning of judging could cause problems such as on a windy day where the wind could blow the bonnet shut and perhaps cause damage or where there were weak bonnet struts where the bonnets could fall abruptly and cause damage. In speaking with the committee members about these concerns before the AGM started (remember, I was on site a day ahead of time when such committee typically arrive to meet as well as a Board of Directors meeting on Friday before, as well as on Sunday after, the AGM concludes on Saturday), to a person all members of the committee felt that Bryan was 100% correct in his concerns but they said that each Chief Judge was to use good judgment and discretion on how to implement the proposed rule change and rules are not to override common sense. When, during the AGM Agenda, the subject of the applicable rule changes arose, the committee heads referenced the conversation I had had with them so every club could hear this, it was emblematic, to me, of a real sense of the JCNA Judging and Concours Committee folks wanting to work with clubs, not necessarily just impose dumb mandates on the clubs. Follow the rules but use good sense in doing so. It was so stated "on the record" at the AGM. Not only the Clubs, but the JCNA Judging and Concours Committee folks wanting rules to the forefront.

In summary, the San Francisco AGM was excellent. The Jaguar Club of Pittsburgh is a member club of the Jaguar Clubs of North America. I believe both organizations are focused and doing the best they can in addressing how to prosper in 2023. If JCNA makes a decision on a dues increase, I suggest let's not kill the messenger since I am telling you the folks running the show are good and smart and honest and capable people.

### Jaguar Club of Pittsburgh Tech Seminar: XK-120 Restoration Panel Fit Challenges and Realities

The introduction of the XK-120 OTS made quite an immediate stir post-war on both sides of the Atlantic. The exhibition of a largely hand-built example of the first 242 wholly aluminum units at the 1949 Earl's Court Auto Show was displayed as a "halo" car for the XK engine to be fitted to the maker's production luxury Saloon.

But Bill Lyons and his colleagues realized very soon that production of the roadster would be necessary given demand across the world due to the car's exquisite style, mighty performance of that very XK engine mounted on a cut-down Mark V Saloon chassis, and ability to build it to a relatively "reasonable" price compared to other similarly attractive exotic sports cars. March 1950, the XK-120 went into "official" production. Aluminum doors, boot and bonnet remained but other core fender/cowl(s) body panels were switched to steel for unit volume production.

To this day, the original genius behind Jaguar's 120 design, performance and appeal are eternal. The car will always carry its reputation enjoyed from the beginning as a masterful achievement, perhaps the most important post-war sports car ever built.

However, the brilliant engineering behind the 120 doesn't mean its coachwork is particularly easy to restore. Even after "mass" production began in 1950, the combination of limited resources available, the relatively few OTS cars built (approximately 6750 for export) and the complexity of the cars' compound curved panels resulting in much hand-fitting and leading of body parts on the line, make reconstruction, panel fitting and operation (doors, boot and bonnet) extremely difficult to dialin, whether using original or modern expertly made panels or patch panels.

The Hahn restoration crew, Ken Como and Rich Aronson are presenting their story of body-off frame restorations of their 120s – Ken's in current progress at Hahn's and Rich's completed many years ago and also maintained at Hahn's.

You will be intrigued with the XK's body dimension and shape "irregularity," once panels are removed and stripped leading to the challenges to "re-tailor" adjoining panels to fit together and to operate properly on the car. Rich and Ken have found, ironically, that both cars - an early 1951 and later 1954 steel models - both have <sup>1</sup>/<sub>2</sub>" variances in their respective cars side-to-side.

### DIRECTIONS TO JCOP MAY 21, 2023 PICNIC @ ROOSEVELT SHELTER IN NORTH PARK

Roosevelt Shelter is located on Walter Road in North Park. While there are many ways to get there (one can use MapQuest or some other GPS navigation tool [although last year a couple folks said their GPS directions were awful] or access the North Park map on the Allegheny County Parks website), some suggested Directions are provided for convenience below but in all instances the Speed Limit in North Park is 25 mph unless marked lower and it is strongly recommended your obey the posted limit:

### If you are coming from the North

If you are coming south down Rt. 8, please know that Wildwood Road has a bridge closed until at least November, 2023 so one cannot go directly on Wildwood Road into North Park. The official detour is that if you are coming south on Rt. 8 you want to turn to go West on Rt. 910 (that corner has the Gibsonia Post Office and a Giant Eagle. Go west for some miles until you come to Hardt Road ( where there is a gas station and stop light) and turn left. Go south on Hardt Road until it ends at Wildwood Road. Turn right onto Wildwood Road and keep going straight into North Park where the name of the road changes to E. Ingomar Road right after an Exxon Gas Station on your right. Go straight past the stoplight at Babcock Boulevard (where the Lake will come into view). Proceed to the next stoplight and turn RIGHT onto Kummer Road. After only a few yards, take the first RIGHT Turn onto Lake Shore Drive. The road splits almost immediately and you will bear LEFT onto Walter Road. Go past the first few buildings and up a hill and when you come to what appears to be an old church on your left, Roosevelt Shelter will appear on your right next to it since we will want some open space to get in and out of the lot and for deliveries of food, etc.

If you are coming south down Rt. 19/McKnight Road, stay on McKnight Road where Rt. 19 splits off and you will immediately come to the Pine Creek Shopping Center on your right (where there is a Target Store and Giant Eagle). Go straight past the first light where there is a Walgreen's but get in the left lane and then the left turning lane for the next stoplight across from where there was a PNC Bank branch and there is the Giant Eagle and a KFC franchise. Turn LEFT onto Blazier Drive and follow that until it "T's" out at E. Ingomar Road. Turn LEFT onto E. Ingomar Road. Go until the stoplight at Kummer Road. Turn LEFT onto Kummer Road. After only a few yards, take the first RIGHT Turn onto Lake Shore Drive. The road splits almost immediately and you will bear LEFT onto Walter Road. Go past the first few buildings and up a hill and when you come to what appears to be an old church on your left, Roosevelt Shelter will appear on your right. Pull into the parking area and park on the side of the lot by Roosevelt Shelter but not right next to it since we will want some open space to get in and out of the lot and for deliveries of food, etc.

### DIRECTIONS TO JCOP MAY 21, 2023 PICNIC (a) ROOSEVELT SHELTER IN NORTH PARK (Continued)

If you are coming from the South or East, get to either Rt. 8 or Rt19/McKnight Road. If you are coming North on Rt. 8, go north past Wildwood Road (where there is a BP Gas Station and McDonalds on your right at the intersection). Keep going North until you come to Rt. 910, which is the official Detour for the Wildwood Road bridge closure. Turn LEFT onto Rt. 910 (you will also see the orange Detour Sign with directions). Go west for some miles until you come to Hardt Road (where there is a gas station and stop light) and turn left. Go south on Hardt Road until it ends at Wildwood Road. Turn right onto Wildwood Road and keep going into North Park where the name of the road changes to E. Ingomar Road right after an Exxon Gas Station on your right. Go straight past the stoplight at Babcock Boulevard (where the Lake will come into view). Proceed to the next stoplight and turn RIGHT onto Kummer Road. After only a few yards, take the first RIGHT Turn onto Lake Shore Drive. The road splits almost immediately and you will bear LEFT onto Walter Road. Go past the first few buildings and up a hill and when you come to what appears to be an old church on your left, Roosevelt Shelter will appear on your right. Pull into the parking area and park on the side of the lot by Roosevelt Shelter but not right next to it since we will want some open space to get in and out of the lot and for deliveries of food, etc.

If you are coming North on McKnight Road, go past all the shopping centers and such. When you pass the McCandless Crossings Shopping area, go straight past the stoplight at Cumberland Road. You will then come to one more stoplight and go straight past that and get in the right lane. In about a quarter mile or so, you will see a sign that says to bear right to Hampton Township. Take that ramp to the right and it will bring you onto E. Ingomar Road. Go to the second stoplight and that will be at the intersection of Kummer Road. Turn LEFT onto Kummer Road. After only a few yards, take the first RIGHT Turn onto Lake Shore Drive. The road splits almost immediately and you will bear LEFT onto Walter Road. Go past the first few buildings and up a hill and when you come to what appears to be an old church on your left, Roosevelt Shelter will appear on your right. Pull into the parking area and park on the side of the lot by Roosevelt Shelter but not right next to it since we will want some open space to get in and out of the lot and for deliveries of food, etc.

If you are coming from the West or any other area not specifically noted above, either check a map to see how to get to one of the above locations and then proceed per the directions or call Stu Benson ahead of time and he can tell you how to best get to the picnic location. For example, if one is North I-79, there is a right lane of the exit so as to then turn right onto Rt. 910 and immediately take the first RIGHT turn onto Brandt School Road. Follow this road until you turn left onto Pine Creek Road and take that until you get to the Pine Creek Shopping Center where you will turn left at a stop sign and immediately turn right onto McKnight Road. From there, follow the directions above "If you are coming south down Rt. 19/
